BROKEN METER CANS:

METER CANS THAT ARE BROKEN WILL BE REPLACED AT THE CUSTOMERS COST UNLESS APPROVED BY THE MANAGER

BILLING WILL BE \$ 85.00 PER HOUR FOR EXCAVATION PLUS ACTUAL COST OF MATERIALS

METER CANS WILL NOT BE REPLACED ON AN EMERGENCY BASIS UNLESS APPROVED BY THE MANAGER

EMERGENCY CALL OUTS:

RURAL WATER DISTRICT # 3 MAYES COUNTY WILL CHARGE FOR ANY CALL OUT THAT IS DECLARED TO BE THE FAULT OF THE CUSTOMER/RESPONSIBLE PART BY THE MANAGER. THIS WILL INCLUDE, BUT NOT BE LIMITED TO, FALSE ASSUMPTIONS OF THE DISTRICTS RESPONSIBILITY FOR LOSS OF SERVICE, DAMAGED WATER MAINS, DAMAGED FIRE HYDRANTS, ETC.

PARTS TO REPAIR DAMAGE WILL BE BILLED AT ACTUAL COST TO THE DISTRICT

EXCAVATION WILL BE BILLED AT \$ 85.00 PER HOUR WITH A 3 HOUR MINIMUM

LABOR WILL BE BILLED AT \$ 40.00 MINIMUM AND \$ 20.00 PER HOUR PER EMPLOYEE THEREAFTER

AFTER HOURS AND HOLIDAY EMERGENCY CALL OUTS:

PARTS TO REPAIR DAMAGE WILL BE BILLED AT ACTUAL COST TO THE DISTRICT

EXCAVATION WILL BE BILLED AT \$100.00 PER HOUR WITH A 3 HOUR MINIMUM

AFTER HOURS LABOR WILL BE BILLED AT \$70.00 MINIMUM AND \$ 35.00 PER HOUR PER EMPLOYEE THEREAFTER

HOLIDAY LABOR WILL BE BILLED AT \$ 100.00 MINIMUM AND \$50.00 PER HOUR PER EMPLOYEE THEREAFTER

WATER LOSS WILL BE BILLED AT \$ 5.25 PER 1000 GALLONS

FAILURE TO PAY REPAIR BILLS WITHIN 30 DAYS TO DUE DATE WILL RESULT IN LOSS OF WATER SERVICE AND A 10% LATE FEE.
