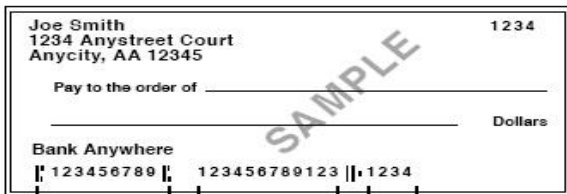

### PAYMENT AUTHORIZATION

This authorization will remain in effect until Rural Water District #3; Mayes County is notified by me in writing to cancel it in such a time as to afford Rural Water District #3, Mayes County and my Financial Institution a reasonable opportunity to act on it. All other changes such as new Financial Institution information will require a new Electronic Payment Authorization Form to be filled out and submitted to Rural Water District #3, Mayes County at least thirty (30) days prior to changes being implemented.

***In the event that Rural Water District #3, Mayes County is charged a NSF fee by the bank or a revoke authorization fee, I understand that I will be liable to pay these fees.***
